SUMMARY OF EXPERIENCE AND QUALIFICATIONS

H.E. Abdoulaye Diop is a career diplomat, skilled negotiator and a proven mediator with over 20 years of experience. With a sound background and track record in **highly strategic and political positions at the national and international levels**, Abdoulaye Diop holds a Master's degree in International Relations from the International School of Public Administration (Paris, France).

Amb. Diop is now serving as **Special Advisor to the Executive Secretary of the African Capacity Building Foundation (ACBF), a Specialized Agency of the African Union**, acting as ACBF Representative, ACBF Liaison Office, Bureau of the **African Union Commission's** Chairperson in Addis Ababa.

Diop more recently served as Minister of Foreign Affairs of Mali as the country was recovering from a political and security crisis. **As Foreign Affairs Minister, Diop worked on behalf of the Malian government as chief negotiator in the drafting of the 2015 Algiers Peace Accords with rebel groups.** This was a critical contribution to peace and stability in Mali and in the Sahel region.

As chair of the Council of Ministers of the G5 Sahel countries, Diop was instrumental in mobilizing international support for the operationalization of the G5 Sahel Joint Force aimed at combatting terrorism and setting a regional development agenda for the Sahel. Serving as Director of the World Food Program (WFP) Africa Office in Addis Ababa, he strengthened a partnership with the African Union on food security and nutrition. As Country Director of WFP in Malawi, Diop repositioned the organization as a partner to the government in food security and social safety nets.

Prior to working with the United Nations, Diop served as Mali's Ambassador to the United States and Senior Diplomatic Advisor to two Presidents of Mali. He received a Doctorate Honoris Causa Degree in Public Service of Chatham University, Pittsburg, Pennsylvania, USA. He is fully bilingual in English and French.

Chief Negotiator on behalf of the Malian Government and leader of the ministerial delegation to the Inter-Malian inclusive peace talks held from June 2014 to May 2015 in Algiers. The negotiations led to the signing of the 2015 Algiers Agreement for Peace and Reconciliation in Mali. The agreement put an end to Mali's fourth Tuareg rebellion. It was a critical contribution to maintaining Mali's territorial integrity, as well as peace and stability in the Sahel;

- Principal government's focal point to the United Nations/MINUSMA for the oversight and monitoring of peace and security in Mali. Oversaw the negotiation, preparation, adoption and implementation of the various resolutions of the UN Security Council on the situation in Mali;
- Regular appearances at the United Nations Security Council briefings and interaction with its members and UN secretariat on the stabilization efforts in Mali ;
- Initiated, chaired, provided oversight and strategic direction and coordination to the High-level Joint Steering Committee UN/Government on the United Nations Development Assistance Framework in Mali (UNDAF+ 2015-2019) co-chaired by the UN Resident Coordinator;
- Launched the SDGs in Mali and championed the establishment of a national framework for the implementation of the Agenda 2030 for sustainable development;
- As Chair of the G5 Sahel Council of Ministers during Mali's rotating chairmanship of this organization (February-December 2017), increased the visibility, credibility and effectiveness of the organization. Developed and successfully implemented a roadmap for Mali's presidency focused on the implementation of the G5 Sahel Joint Force. Provided political, technical and financial support for the operationalization of the military force, with strong coordination with the African Union, the United Nations and the European Union;
- Planned and organized the International Conference on Rebuilding Mali held at the OECD in Paris (Oct. 2015), which successful raised USD\$3.2 billion for the economic recovery, reconstruction and implementation for the Algiers peace agreement in Mali;
- Organized and coordinated the political and diplomatic efforts for the Africa-France Heads of State and Government Summit (55 countries) held in Bamako, Mali (Jan. 2017), which resulted in the adoption of the Bamako Declaration on Partnership, Peace and Economic Development;
- Acted as Special Envoy and Represented the President of Mali on missions to other heads of states, to summits and other international fora (UN Climate Summit, UNGA, AU and OIC Summits);
- Led Mali's ministerial delegations to international conferences and bilateral partnership commissions in Africa, Europe, Middle East and Asia.
